The participants will submit “Pay Order or Demand draft” in favor of Ministry of Poverty Alleviation and Social Safety, Islamabad of Rs. 10,000/- (refundable) for participation in auction and placed on E-PAD and submit the same (in original) before the Section Officer (General) of this Ministry.
- V. Sale shall be made to the bidder offering the highest price. In the event of dispute between the bidders, the dispute shall be decided by the Grievance Committee and decision will be binding on both parties.
- VI. The successful bidder will deposit 25% of total auctioned amount on the same day and remaining amount will be deposited with in three days (03) days, positively.
- VII. The successful bidder will take away auctioned items within three (03) working days, in case of failure 10% of total value shall be charged as rent / penalty.
- VIII. The successful bidder will pay all the prevailing, Government Taxes / duties as admissible under the rules.
- IX. Auction items will be handed over after making the full payment.
